### MEMORANDUM OF UNDERSTANDING BETWEEN JHANJI HEMNATH SARMA COLLEGE, JHANJI, SIVASAGAR, ASSAM AND NGO 'ARANYAM', GELEKY, SIVASAGAR, ASSAM

Memorandum of Understanding (MoU Jhanji Hemnath Sarma College, Jhanji, Sivasagar, Assam and Aranyam, NGO, Geleky, Sivasagar, Assam have reached the following understanding:

### Paragraph I

#### **Objective and Principles**

  and cooperation in the field of environment related activities.
- 3. The Sides will encourage the following cooperative activities, in particular:
  - a) The effort towards the protection of environment jointly in the locality.

- c) Joint Plantation Program.
- d) Organizing seminar, workshop and awareness program jointly on environmental issues.
  - e) IQAC and NSS Unit of Jhanji H.N.S College will execute the operations.

### Paragraph III

### Implementation and Funding

The cost of cooperative activities may be funded as mutually determined. All cooperative activities under this MOU will be subject to the availability of funds to the Sides.

### Paragraph IV

### **Dispute Settlement**

The Sides will consult together upon request of either side regarding any matter relating to the terms of this MOU and will endeavour jointly in a spirit of cooperation and mutual trust to resolve any difficulties or misunderstandings which may arise.

### Paragraph V Amendment

This MOU may be amended by mutual written consent of the Sides.
