- Soft copy of papers, composed in MS Word 2007/2010/2016/2021 following the latest guidelines of **MLA** or **APA** format, must be submitted, as an email attachment. Use the MS Word template above for preparation of your research paper and submission.
- The articles in Assamese language must be submitted in PDF format along with editable file.
- Use the **Times New Roman** font and Select **A4 size** paper with **Normal Margin**, i.e., with **1inch** space on all four sides. Line spacing is **1.5**.
- The **title** (of not more than 10 words) should be in **12pt bold**; the name(s) of author(s) should be in **12pt**; the affiliation(s) should be in **12pt italic**.
- In case of there being two authors, the corresponding author should be indicated by a “*” and the email address should be given (please remove the hyperlink). The document should be centred till this point.
- Leave a line between the title and the author affiliation, and another before the abstract body.
- The abstract body (one paragraph, 12pt, justified) should not be more than **200** words.
- The abstract must be followed by 05 (five) **keywords** (maximum).
- The research papers are expected to have the following parts: Introduction, Objectives, Methodology, Hypothesis (Optional), Discussion, Conclusion and List of Works Cited.
- **Quotations** must be within double inverted commas followed by the surname of the (first) author and page number of the source separated by a comma given within brackets. If there are more than one consecutive quotations from the same text then only the page number is to be given within brackets.

Example:

“She stooped down again and began to pick up her things” (Phukan, 36). ... “Rukmini assured him again that she was perfectly all right” (37).

- **List of Works Cited** should be arranged in alphabetical order of the surname of the author (or that of the first author in case of multiple authors) of the book, article etc.

referred to, without abbreviating any word in the title and leaving a line between two references. Kindly follow the guidelines given below:

i. For books:

Surname, Name of Author. *Title of Book in Italics*. Place of Publication: Publisher. Year of Publication. Type of the source, i.e., Print/ Web.

Examples:

Bloch, J. and Crosby, C. *Creating a Space for Virtual Democracy*. USA: Essential Teacher. 2006. Print.

Phukan, Mitra. *The Collector's Wife*. New Delhi: Zubaan and Penguin Books India. 2005. Print.

ii. For articles from Scholarly Magazines:

Surname, Name of Author. "Title of the Article". *Title of Magazine in Italics*. Volume number, Issue Number (Year). Page number(s). Type of the source, i.e., Print/ Web.

Example:

Striner, Richard. "Political Newtonism: The Cosmic Model of Politics in Europe and America." *William and Mary Quarterly*. Volume 5, Issue 3. 583-608. Print.

iii. For newspaper articles:

Surname, Name of Author. "Title of the Article". *Title of Newspaper in Italics*. Date, Edition. Page number(s). Type of the source, i.e., Print/ Web.

Example:

Jeromack, Paul. "This Once, a David of the Art World Does Goliath a Favor." *New York Times*. 13 July 2002, late ed. 7. Print.

iv. For Website and E-books:

Surname, Name of Author. *Title of Book in Italics*. Publisher. Date of Publication. Web. Date of access. URL.

Example:

Eaves, Morris, Robert Essick, and Joseph Viscomi, eds. *The William Blake Archive*. Lib. Of Congress, 28 Sept, 2007. Web. 21 Nov, 2020. <<http://www.blakearchive.org/blake/>>

N.B.: Author(s) may kindly contact the editorial board in case of any confusion regarding formats for referring to sources other than those mentioned above.

- **Biographical information** of the author(s) in the third person must be included at the end. The maximum number of words is **60**. [Font: Times New Roman; Font size: 12; Spacing: Single space; Alignment: Justified]
- All contributors must e-mail their papers to the e-mail ID **montukumarborah@gmail.com** mentioning in the subject line "**Paper for Publication**". Acceptance of your paper will be communicated to you by email. A maximum of two writers per submission is allowed.
- The last date of submission of paper is **15.07.2022**.

- The journal will be published in the last part of **July, 2022**.
- Authors will have to pay a publication fee of **Rs. 1,000.00** (Rupees one thousand only)
